- Members of the public who wish to offer public comment during the meeting may do so in person by
  providing written request in advance, by 12:00 p.m. on Tuesday, August 8<sup>th</sup> to IAC@calstate.edu. The
  request should also identify the agenda item the speaker wishes to address. Efforts will be made to
  accommodate each individual who has requested to speak.
