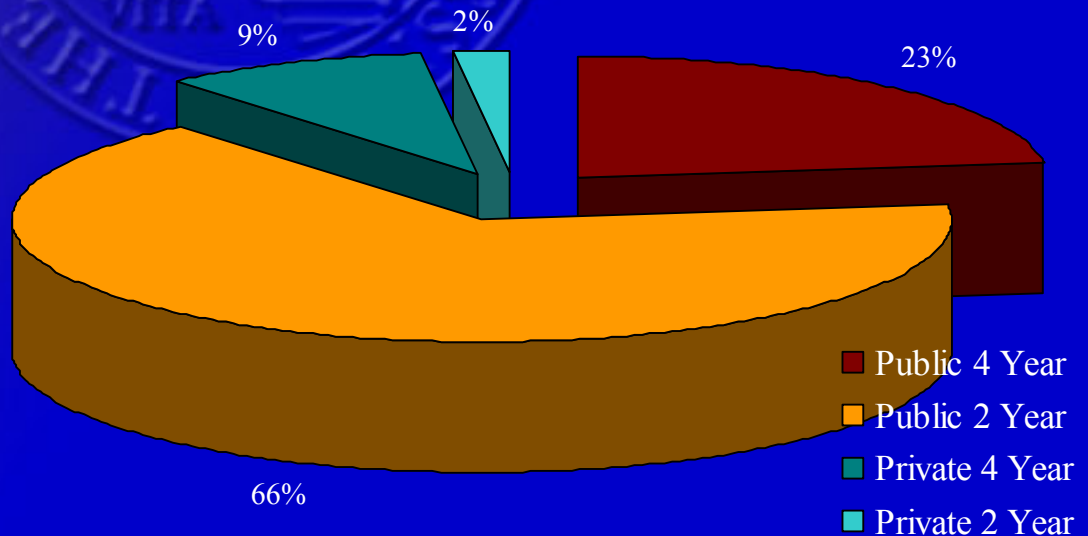

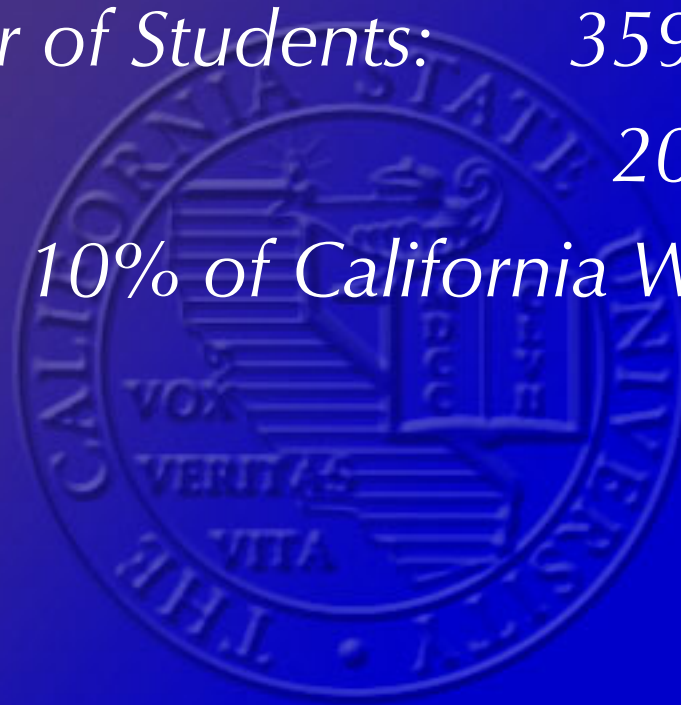

Board of Trustees

Donahoe Higher Education Act 1960 established Board of Trustees

- ◆ *25 Trustees (24 voting)*
- ◆ *5 ex officio*
- ◆ *Alumni Council*
- ◆ *Faculty Trustee (Governor appointed)*
- ◆ *2 Student Trustees (Governor appointed)*
- ◆ *16 Members (Governor appointed)*
- ◆ *Governor is President of the Board*
- ◆ *Meet 6 times each year*

Constitution of the CSU Academic Senate

Duties and Responsibilities

“It shall be the purpose of the Academic Senate of the California State University to promote excellence in the California State University; to serve as the official voice of the faculties of the California State University in matters of systemwide concern; to be the formal policy-recommending body on systemwide academic, professional and academic personnel matters; to ensure the joint responsibility of the Academic Senate and the Trustees in criteria and standards to be used for appointment, promotion, evaluation and tenure of academic employees; to be the primary consultative body on the academic implications of systemwide fiscal decisions; and to assume such other authority and responsibilities and to perform such functions as delegated to it by the Chancellor or the Trustees of the California State University.”



Senate System and Inter-Segmental Roles

- ◆ *“The Academic Senate shall be consulted on the creation of systemwide and intersegmental committees, conferences, or task forces designed to deal with educational, professional, or academically related fiscal matters, including the charge and composition of such bodies.”*

Intellectual Property Task Force- 2002-2002

- ◆ *Professor Paul Spear, CSU Chico, Chair*
- ◆ *To review and update booklets, “Fair Use of Copyrighted Works”(1995) and “Ownership of New Works at the University.” (1997)*
- ◆ *Address issues of author’s rights in light of new technologies and the current legal context.*
- ◆ *Address issues of multiple authors’ rights, including situations in which one or more students are involved in the creation of intellectual property.*
- ◆ *Address ownership issues regarding classroom materials created in electronic formats, made available on the World Wide Web, or otherwise distributed electronically.*

- ◆ *CSU Senate appoints to IMPAC (Intersegmental Major Preparation Advisory Committee)*
- ◆ *CSU Senate Appoints to Joint Doctoral Board- UC & CSU*



California Education Roundtable

- ◆ *Fosters, promotes and coordinates intersegmental programs between and among secondary and postsecondary education segments in California.*
- ◆ *Members: Chair of Association of Independent California Colleges and Universities; Chancellor of CCC, Chancellor of CSU, President of UC, Director of California Postsecondary Education Commission and State Superintendent of Public Instruction*



ICAS

- ◆ *Six members appointed by each of the Academic Senates of UC, CSU & CCC.*
- ◆ *Development & Implementation of IGETC- Intersegmental General Education Transfer Curriculum*
- ◆ *Development of Statements of Competencies Expected of Entering Students- English, Math, Science*
- ◆ *Advises educational officials and policy makers in California*



Intersegmental Coordinating Council

- ◆ *Composed of the leaders of the five educational segments and the California Postsecondary Education Commission-Chair of CSU Senate is member*
- ◆ *“To oversee and coordinate intersegmental programs and activities undertaken by the five segments.”*
- ◆ *Carries & recommends joint budget items- e.g. ASSIST data system*



Intersegmental Coordinating Council- 2

- ◆ *Charge-to determine how intersegmental efforts can be strengthened ; seek to avoid duplication and gaps; develop proposals for improvement .*
- ◆ *Committees*
 - ◆ Transfer and Articulation
 - ◆ Curriculum and Assessment
 - ◆ Outreach and Student Preparation
 - ◆ Improvement of Teaching
 - ◆ Technology

Relation to Campus Academic Senates

- ◆ *“The Academic Senate of the CSU shall have no authority over those matters delegated to the individual campuses by the Chancellor or Trustees..”*
- ◆ *The campus senates may suggest items for consideration by the Academic Senate and may make recommendations to matters before the Academic Senate, CSU, either through the campus representatives or directly to the Academic Senate.*



Campus Academic Senates- 2

- ◆ *“To provide adequate communications with the faculties of the campuses, the Academic Senate, CSU shall circulate to the senate and president of each campus such materials as agendas for and minutes of its meetings, committee reports, and information on pending matters.”*
- ◆ *Campus academic senate chairs meet four times a year with the Executive Committee and standing committee chairs to exchange information and to discuss common issues of concern.*



Senate and CFA Relationships

- ◆ *The Higher Education Employer-Employee Relations Act (HEERA) states the following:*
- ◆ *“scope of representation’ (role of CFA) means and is limited to wages, hours of employment, and other terms and conditions of employment.”*



Senate and CFA Relationships-2

- ◆ *HERA also states: “The academic senates and trustees have joint responsibility specifically for criteria and standards for appointment, promotion, evaluation and tenure, but...CFA has ‘the right to consult and be consulted on these matters.’”*
- ◆ *“Communications from academic senates to the CSU, or to the CSU and CFA, expressing opinions or seeking consultation on matters within scope are not prohibited. To the contrary they are clearly permitted.”*
